

Looking to run for elected office? Filing packets are available at the Oxford Township Clerk's Office (300 Dunlap Rd.) The office is open from 8 a.m. to 5 p.m. Monday through Friday.

Oxford Township Board of Trustees

All seven seats on the Oxford Township Board of Trustees are up for election. This includes supervisor, clerk, treasurer and four trustee positions. Each has a four-year term of office that begins on Nov. 20, 2024.

Township elections are partisan elections, so candidates appear on both the Aug. 6 primary ballot and Nov. 5 general election ballot.

A candidate must be at least 18 years old, a township resident for at least 30 days and a qualified elector of the township by the filing deadline.

To appear on the ballot, partisan candidates must file nominating petitions containing a minimum of 20 registered-voter signatures (but no more than 50 signatures) and an affidavit of identity. These documents must be submitted to the township clerk's office by **4 p.m. April 23**. Candidates can pay a nonrefundable \$100 fee in lieu of filing nominating petitions.

Any candidate who wishes to withdraw his or her name from the ballot must do so by **4 p.m. April 26**.

Oxford Village Council

Two of the five nonpartisan Oxford Village Council seats are up for election. Each has a four-year term that expires on Nov. 15, 2028. Village candidates will appear on the Nov. 5 general election ballot.

Candidates must file an affidavit of identity and nominating petitions containing the signatures of 25 to 50 registered village voters.

Under the village charter, a candidate must be at least 21 years old, an elector and a village resident for at least 6 months immediately prior to the date of election.

To appear on the ballot, nominating petitions and the affidavit of identity must be submitted to the township clerk's office by **4 p.m. July 23**.

Oxford Board of Education

School board candidates are required to pick up and file their nominating petitions at the same place – the Oakland County Clerk's Office Election Division (1200 N. Telegraph Rd., Pontiac), **not** the Oxford Township Clerk's Office.

The school board is nonpartisan and candidates will appear on the Nov. 5 general election ballot.

Candidates must file an affidavit of identity and nominating petitions containing a minimum of 40 signatures (but no more than 100 signatures) from registered voters

living in the Oxford school district. Candidates have the option to pay a nonrefundable \$100 filing fee in lieu of submitting petition signatures.

Candidates have until **4 p.m. July 23** to file. A candidate must be a U.S. citizen and a qualified and registered elector of the Oxford school district by the filing deadline.

A candidate who wishes to run as a write-in candidate must file a declaration of intent with the Oakland County Clerk's Office Election Division no later than **4 p.m. Oct. 25**.

Oxford Township Parks and Recreation Commission

All five seats on the Oxford Township Parks and Recreation Commission are up for election. Terms begin on Nov. 20, 2024 and expire on Nov. 20, 2028.

Commission candidates will appear on the Aug. 6 primary ballot and Nov. 5 general election ballot. A candidate must be at least 18 years old, a township resident for at least 30 days and a qualified elector of the township by the filing deadline.

To appear on the ballot as a partisan candidate, a person must file nominating petitions containing a minimum of 20 registered-voter signatures (but no more than 50 signatures) and an affidavit of identity. These documents must be submitted to the township clerk's office by **4 p.m. April 23**.

Oxford Public Library Board of Trustees

All six non-partisan library board seats are up for election on the Nov. 5 ballot. Each has a four-year term of office.

Candidates must file an affidavit of identity and nominating petitions containing at least 40, but no more than 100, registered-voter signatures. The required documents must be submitted to the township clerk's office by **4 p.m. April 23**.

A nonrefundable \$100 fee may be paid in lieu of submitting a petition. Candidates must be registered and qualified electors of Oxford Township by the filing deadline.
